Fire Department LODD Checklist

- Oklahoma State Firefighters Association 800-308-5336 (8:00am – 4:30pm) after hours, (405) 326-3408
 - + Members receive \$4,000 AD&D benefit
 - + Member LODD Death Benefit \$2,000 typically delivered within 24 hours to the family
 - + Brent Hatcher Benevolent Fund Benefit (optional membership for \$20/year per member) \$5 donation times the number of members of the fund currently \$2,100

 - + Local fire department chaplain

- Worker's Compensation Claim
 - + Compsource Mutual <http://compsourcemutual.com/>
 - + *Any job-related injury should be reported to your supervisor as soon as possible. Failure to timely report an injury may result in the loss of benefits. An employee must report a single event injury to the employer within 30 days or medical treatment must be obtained within the 30-day period. In cases of occupational disease or injuries caused by "repeated" trauma, an employee must give notice to the employer within 90 days of the employee's separation from employment.*

- Oklahoma Firefighters Pension and Retirement System – Martha Pierce 800-525-7461
 - + \$5,000 death benefit
 - + Start monthly pension benefits for spouse (continues for rest of spouse's life). Volunteer benefit for less than or up to 20 years service is currently just over \$150/month
 - + Children's tuition waiver to Oklahoma Colleges or Technology Centers
